#### **DCSS-Central Campus**


- The school had a Thanksgiving lunch for everyone at the school.

#### **Student Voice**

Students from across the district are participating in the Student Voice program. Students reflected on where they left the program from last year and identified three themes they want to work on for this year: Education (ie: access to courses), Transitions, and Mental and Physical Health.

The next meeting is scheduled for January.



#### **Class Size/Composition and Ratios**

As of September 30<sup>th</sup>, 2019, the district has 11 schools not in compliance with class size or composition maximums as defined in LOU 17. The district met with the local PRSTA and determined best efforts were given to find solutions and remedies have been applied for those circumstances.

The district has met and exceeds the ratio for Teacher Librarians; however, at this time, the district has a shortfall in the combined ratios of SERT, LAT and ELL, as well as, Secondary Counsellors.

# Reports from the Secretary-Treasurer:

#### **Final Enrollment**

The final enrollment for the district was reported at 3683.81 FTE (an increase of 74.81 FTE from last year). Three schools with the largest increase in FTE are Crescent Park Elementary (31) Don Titus Elementary (27) and Ecole Frank Ross Elementary (30).

#### **Executive Compensation Disclosure & SOFI Report**

The Acting Secretary-Treasurer presented the 2018-19 Executive Compensation Disclosure Report and the Statement of Financial Information Report. The reports are sent to the Ministry of Education and will be posted on the school district website.

#### **Pouce Coupe Portable**

The second portable at Pouce Coupe Elementary School has been delayed and is now scheduled to arrive mid-November. Once it is delivered, the hook up will go quickly as the site work has been completed.

#### Trustee Items:

Trustee Borton presented out on the transportation meeting that occurred in Chetwynd to discuss the crosswalk/intersection on Highway 97. The Ministry of Transportation has jurisdiction over this intersection and will review the concerns, issues and recommendations that were presented at the meeting.
