**QUALIFICATIONS FOR OFFICE**

A person is qualified to be nominated, elected, and to hold office as a member of local government if they meet the following criteria:

- Canadian citizen;
- 18 years of age or older;
- resident of British Columbia for at least 6 months immediately before the day nomination papers are filed; and
- not disqualified by the *Local Government (Municipal) Act* or any other enactment from voting in an election in British Columbia or from being nominated for, being elected to, or holding office.
